GRAMMY-WINNING SAXOPHONIST, COMPOSER AND LONG-STANDING JAZZ AT LINCOLN CENTER ORCHESTRA MEMBER TED NASH BRINGS *PRESIDENTIAL SUITE*, *EIGHT VARIATIONS ON FREEDOM* TO TILLES CENTER ON NOVEMBER 9

A Powerful Evening of Jazz and History Featuring Live Readings by Long Island Community Leaders

Brookville, NY [October 2025] – Tilles Center for the Performing Arts at Long Island University is proud to present **Ted Nash Sextet**: *Presidential Suite, Eight Variations on Freedom* on **Sunday, November 9 at 7 pm** in the **Krasnoff Theater**, in an event **presented in collaboration with Jazz at Lincoln Center**.

Presidential Suite is an eight-movement jazz composition inspired by the words of world leaders who shaped the 20th century. Composed and arranged by **Grammy Award-winning saxophonist and longtime Jazz at Lincoln Center Orchestra member Ted Nash**, the suite transforms the rhythms and cadences of historic speeches into lush, thrilling music that honors the voices of Franklin D. Roosevelt, John F. Kennedy, Winston Churchill, Nelson Mandela, Jawaharlal Nehru and others whose messages of freedom and justice continue to resonate today.

"When I first conceived *Presidential Suite*, I wanted to create a musical dialogue between history and humanity," says **Ted Nash**. "The words of these leaders still speak to freedom, justice, and empathy. Hearing them voiced by community leaders today brings new meaning, connecting past ideals to our present hopes."

"Ted Nash's *Presidential Suite* is a profound artistic statement that combines music, history and social consciousness," shares **Tom Dunn**, **Executive & Artistic Director**, **Tilles Center**, and **Dean of LIU's College of Arts & Design**. "We're honored to bring this work to Long Island and to involve our own leaders in a performance that reminds us how words and art can inspire action and understanding."

Originally commissioned and recorded by **Jazz at Lincoln Center**, *Presidential Suite* earned two Grammy Awards, for **Best Large Jazz Ensemble Album** and **Best Instrumental Composition**, and has since been performed worldwide to critical acclaim.

Nash, a longtime member of the **Jazz at Lincoln Center Orchestra** under Wynton Marsalis, is celebrated for his bold and imaginative approach to composition. His work bridges generations and genres, creating an ongoing conversation between the spoken word and the freedom of jazz improvisation.

In this special Long Island presentation, Nash and his sextet will be joined by a distinguished group of **Long Island community leaders** who will deliver live readings of the historic speeches that inspired each movement:

Dr. Sen has been credited for many pioneering contributions, including the creation of the Surgical Technology program at Long Island University, and advocacy for the opioid crisis and healthcare for formerly incarcerated individuals.

Dr. Sen has been an invited speaker at the United Nations, World Parliament of Religions, Harvard Medical School, Massachusetts Institute of Technology, City University of New York, among others and has appeared at various media outlets including CNN, MSNBC, and PBS.

Dr. Sen is also a filmmaker whose recent Documentary, *Broadway, Bars and Fortune* on formerly incarcerated individuals and their indomitable courage to return to their lives, has been acknowledged globally by major film festivals and social justice institutions.

Dr. Isma H. Chaudhry, MD, MPH, Past President & Chair, Islamic Center of Long Island Dr. Chaudhry is a physician, educator, and interfaith leader recognized for her work in health equity and community engagement. The first female president and chair of the Islamic Center of Long Island, she serves as Executive in Residence at Hofstra University's Public Health Programs and advises organizations on diversity, inclusion, and cultural humility.
